6. The successful highest bidder should remit the full amount in cash before taking delivery of material from this offices premises.

TERMS & CONDITIONS:

Subject: - Auction of Unserviceable Items

1. The location and the present condition of Bid "As is where is basis" in the Broadcasting House, Parliament Street, New Delhi.
2. An amount of Rs.16,000/- or 10% of the value of the amount quoted by the tenderer, whichever is higher shall be deposited by the Tenderer along with their Bid in the form of a Bank Pay Order/ DD Drawn in favour of Station Director, All India Radio, New Broadcasting House, New Delhi as Earnest Money. The EMD shall be returned / adjusted on completion of the Bids. The bids security will be forfeited in case the successful tenderer refuse to accept the bids.
3. The bid of the highest responsive bidder will be acceptable and the successful tenderer will have to arrange manpower for carrying the unserviceable material, within 4 days after depositing the accepted bid amount with the cashier of AIR, New Delhi.
4. In case, the total quantity to be disposed off can not be taken up by the highest acceptable bidder the remaining quantity will be offered to the next higher bidder at the prize offered by the highest acceptable bidder.
5. The goods will be released after deposit of full payment from the successful bidder.
6. If the selected bidder does not lift the goods within 10 days of intimations (sale order) the bids security shall be forfeited and other action initiated including re-sale of the goods in question at the risk and cost of the defaulter tenderer.
7. Tender/ Quotation if any received after the specified time & date, will not be entertained under any circumstances.
8. Safety and insurance of the workers will be responsibility of the tenderer. They will not have any claim/ liability on AIR,
9. Subletting the contract to any other person/ agency/ firm will not be permitted.
10. The DDG (E), AIR, New Delhi reserve the right to modify or revise the terms & condition, if required.
11. Any extra infrastructure required for removing of the goods will be arranged by the tenderer.
12. If any worker of the successful tender indulges in any unlawful activity or causes any loss/ damage to AIR belonging in the said holdings, amount of loss caused by the worker shall be recovered from the Bid Security of successful tenderer.
13. All disputes, whatsoever shall be referred to sole arbitration of Head of the Engineering Wing, All India Radio, New Delhi and his decision shall be final and binding on the agency.
14. All the matters subject to the jurisdiction of Delhi Court.
15. The Deputy. Director General (E), AIR, New Delhi reserves the right to reject any or all the tenderers without assigning any reason thereof.
