1. The criteria and terms & conditions for the firms in respect of the above works shall be as under :-

The specialized firms and approved contractors should produce definite proof along with application from the appropriate authority of having satisfactorily completed similar works during the last 07 years ending **November – 2011** as specified below :-

Two similar works each of value not less than 60 % of the estimated cost put to tender Or one similar work of value not less than 80 % of the estimated cost put to tender in Central or State Government / Central or State Government Undertaking / Central or State Government Autonomous body.

Definition of similar works mean: - Operation of Central AC Plants & preventive checking of AC plants, chilled & condenser water pump sets, AHU's etc.

2. Attested copies of completion certificate issued by the officer of the client department of the rank of Executive Engineer or equivalent officer will have to be furnished along with the application. The completion certificate must clearly indicate.

- a. Name of work.
- b. Value of the work.
- c. The date of completion work.
- d. Performance of the work.

3. The firms who wish to tender for the work may submit their application along with enclosures in sealed envelop by 3:00 P.M. on **26.12.2011** and shall be opened at 3.30 P.M. on the same day in the office of EE (E) - P, CCW, AIR, Kingsway Camp, Delhi in the presence of representatives of the firms who would like to be present.

4. The firms should submit P.Q. application in sealed envelope along with required documents. Name of work should be inscribed on top of envelop along with due date of opening.
5. The firm should submit the copy of registration with sales tax authority (Work contract cell), *EPFO & ESIC*
6. If any information furnished by the applicant is found incorrect at later stage, such agency will be liable to be debarred form tendering / taking up of work. The department reserves the right to verify the particulars furnished by the applicant independently.
7. The date of sale and opening of tender papers shall be intimated separately to the firms who fulfill the prescribed P.Q. criteria and approved by the competent authority.
8. The firm will have to deposit earnest money **at the time of submission of tender paper.**
9. No application shall be entertained after due date and time.
10. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion of work to the last date of receipt of application for pre-qualification.
