Earnest money shall be deposited along with tender document in receipt Treasury Challan/ Deposit at Call receipt of a scheduled Bank/ fixed deposit receipt of a Scheduled bank/ Demand drat of the scheduled bank issued in favour of "**Executive Engineer(C), PB(BCI) EE(C), Metro Div-II, CCW, AIR, Kingsway Camp, Delhi**". The FDR shall be accepted only if it is valid for a period of Six months or more after last date of receipt of the tender. Both sealed envelopes (EMD and Tender document) marked as earnest money and tender shall be submitted together in another sealed envelope superscripted with name of work and due date of opening. The envelope marked tender shall be opened whose Earnest Money, placed in the other envelope marked as Earnest money, is found to be in order.

The tender forms will be issued to the eligible contractors provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed three similar works (Building Work) each of value not less than Rs. 8.10 Lakh or Two works each of value not less than Rs. 10.13 Lakh or one work of value not less than Rs. 16.20 Lakh in the last 7 years ending 30.11.2011.

Intending tenderers must produce original documents such as valid Registration, Partnership deed, sales tax (Works Contract Cell)/ VAT registration certificate along with attested true copies enclosed with the application before tender papers can be sold to them.

The enlistment of the contractors should be valid on the last date of sale of tenders. In case only the last date of sale of tender is extended, the enlistment of contractor should be valid on the original date of sale of tenders. In case both the last date of receipt of application and sale of tenders are extended, the enlistment of contractor should be valid on either of the Two date i.e. original date of sale of tender or on the extended date of sale of tenders.
