The criteria and terms and conditions for the specialized firms in r/o above works shall be as under:-

1. Only those firms who have satisfactorily two similar works of 60% or one work aggregating to 80% of estimated cost in Central / State Govt. / Govt. undertaking / Autonomous body in the last 7 years ending July-2010.
2. Completion certificate issued by the officer of the Client Department not below the rank of Executive Engineer or equivalent will have to be furnished along with the application. The completion certificate must clearly indicate.
 - a. The date of completion of work.
 - b. Nature of work.
 - c. That the work has been completed satisfactorily.
3. The firms should be registered with Sales tax Authority (Work Contract Cell) and must submit latest Tax Clearance Certificate (VATCC) and TIN issued by Sales Tax Department (work Contract Cell).
4. Application along with enclosures shall be submitted to EE(E)-II,CCW,AIR, Pushpa Bhawan, New Delhi in a sealed envelope which shall be subscribed "PQ application for the aforesaid work".
5. The firms who wish to tender for the work may submit their application by 3.00 P.M. on above date. The same shall be opened at 3.30 P.M. on the same day in the office of EE(E)-II, CCW, AIR, Pushpa Bhawan, New Delhi in the presence of representatives of the firms who would like to be present.
6. The department reserves the right to reject any application without assigning any reason or to restrict the list of pre-qualified contractors to any number deemed suitable by it, if too many applications are received satisfying the basic PQ criteria.
7. If any information furnished by the applicant is found incorrect at a later stage, he will be liable to debar from tendering/taking up of work. The department reserves the right to verify the particulars furnished by the applicant independently.
8. The date of sale and opening of tender papers shall be intimated to the firms who fulfill the prescribed PQ criteria and are approved by the competent authority.
9. No application shall be entertained after due date and time.
