The Criteria and terms & conditions shall be as under:-

1. The specialized firm (i.e. non approved contractors) should produce definite proof along with application from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works during the last 07 years ending July-2010 as specified below:-

Two similar completed works of aggregate cost not less than the amount equal to 60%. Or One similar completed work of aggregate cost not less than the amount equal to 80% of estimates cost in central/state Government/Government under taking/Autonomous body.

The definition for similar work is as under:

Ductable split AC units.

2. Completion certificate duly attested issued by the officer of the client department not below the rank of Executive Engineer or equivalent will have to be furnished alongwith the application. The completion certificate must clearly indicate.
 - a. The date of completion work.
 - b. Nature of work.
 - c. That the work has been completed satisfactorily.
3. The firms should be registered with sales Tax Authority (Work Contract Cell) and must submit Tax Clearance Certificate (VATCC) and T.I.N issued by Sales Tax Department (Work contract cell)
4. Application alongwith enclosures shall be submitted to EE (E)-II, CCW: AIR, Pushpa Bhawan, New Delhi in a sealed envelop which shall be subscribed "PQ application for the said work"
5. The firms who wish to tender for the work may submit their application by 3:00 P. M on 30-08-10 the same shall be opened at 3:30 PM on the same day in the office of EE (E)-II, CCW: AIR, Pushpa Bhawan, New Delhi in the presence of representatives of the firms who would like to be present.
6. The department reserves the right to reject any application without assigning any reasons or to restrict the list of Pre-qualified contractors to any number deemed suitable by it, if too many applications are received satisfying the basic P.Q. criteria.
7. If any information furnished by the applicant is found incorrect at later stage, such agency will be liable to debar from tendering / taking up of work. The department reserves the right to verify the particulars furnished by the applicant independently.
8. The date of sale and opening of tender papers shall be intimated to the firms who fulfill the prescribed P.Q. criteria and approve by the competent authority.
9. No application shall be entertained after due date and time.
