PRESS TENDER NOTICE

The Executive Engineer(C), CCW, AIR, Mandi House Project Division, 11th floor, Soochna Bhawan, New Delhi-110003 invites, on behalf of the President of India, sealed item rate tenders from approved and eligible contractors of CPWD and those of appropriate class of contractors enlisted in the Department of Telecommunications (BSNL/MTNL), Department of Post, MES, Railways and State PWD(B/R) or State Govt's organizations dealing with Building and Roads of Delhi State upto 3.00 P.M. on 17/08/2010 for the following work:-

Tender documents excluding standard form can be obtained from the O/o EE(C), CCW, AIR, Mandi House Project Division, New Delhi, upto 16:00 hrs on all working days on payment of Rs.1,500/- (Rs. one thousand five hundred only) in cash (non-refundable) towards the cost of tender. Earnest money shall be deposited along with tender document in receipt Treasury Challan/Deposit at Call Receipt of a Scheduled Bank/fixed deposit receipt of a Scheduled bank/Demand draft of a scheduled bank issued in favour of Executive Engineer(C), Prasar Bharati, CCW, AIR, Mandi House Project Division, New Delhi. A part of the earnest money is acceptable in the form of bank guarantee also. In such case, 50% of the earnest money or Rs.20 lakhs, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee issued by a scheduled bank having validity for six months or more after last date of receipt of tender. The FDR shall be accepted only if it is valid for a period of SIX months or more after last date of receipt of the tender. The tender and the earnest money shall be placed in separate sealed envelopes each marked "Tender" and "Earnest Money" respectively. Both the envelopes shall be submitted together in another sealed envelope with the name of work and due date of opening written on envelope

To become eligible for issue of tender, the tenderer shall have to furnish an affidavit as under :-

I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for tendering in CCW in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee.

The tender forms will be issued to the eligible contractors provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed three similar works (similar work means Building work of multistoried buildings with RCC frame structure) each of value not less than Rs.220 Lakhs (Rupees Two Hundred Twenty Lakh only) or two works each of value not less than Rs.280 Lakhs (Rupees Two Hundred Eighty only) or one work of value not less than Rs.450 Lakhs (Rupees Four Hundred Fifty Lakh only) in the last 7 years ending 31.07.2010

Intending tenderers must produce original documents such as valid Registration, Partnership deed, Bank solvency certificate, sales tax (Works contract cell)/VAT registration certificate along with attested true copies enclosed with the application before tender papers can be sold to them.

The enlistment of the contractors should be valid on the last date of sale of tenders. In case only the last date of sale of tender is extended, the enlistment of contractor should be valid on the original date of sale of tenders. In case both the last date of receipt of application and sale of tenders are extended, the enlistment of contractor should be valid on either of the two date i.e. original date of sale of tender or on the extended date of sale of tenders.
